



**Al and Carolyn Schiller
Distinguished Service Award**

Deadline: April 1

Purpose:

The Al and Carolyn Schiller Distinguished Service Award allows recognition of anyone who has demonstrated exceptional and meritorious service to ACVS. Conferring this service award recognizes and honors recipients for outstanding contributions related to ACVS functions.

Eligibility:

1. This award is open to any person.
2. The individual will have demonstrated service to the ACVS for at least fifteen years. The Board of Regents will consider exceptions in rare and unusual circumstances.

Selection Criteria (required information to be completed on pages 3-4 of the nomination form):

- Meritorious service to the ACVS over a period of not less than 15 years, including actions that advanced the practice of veterinary surgery for all veterinary professionals.
- Provide a complete list of the nominee's committee service and other contributions to ACVS.

Nomination Procedure:

A complete nomination packet will include:

- the nomination form (fillable),
- the nominee's curriculum vitae, and
- at least two letters of support from ACVS Diplomates.

The nominator will submit the complete nomination packet in one email, with the required nomination form, CV, and letters attached, to Joanne Magro, executive assistant, jmagro@acvs.org. The ACVS office must receive all nominations and supporting documents no later than April 1 of the year of consideration.
